Sherwood Families -



This has been another wonderful school year for our Sherwood community. We were very excited to learn that Sherwood

School District had the highest Annual Progress Report (APR) score of all of the Cass County school districts from the 2021-22 school year. Sherwood gained 82.4% of the possible points. The biggest area for improvement will be on individual student growth on the state assessment. Although we only received the scoring in March, we have been working all year to identify where each student struggles and use interventions and various strategies to fill the gaps and help our students to be more successful. This has been a year-long process of growth and improvement rather than us waiting until the last minute to help our students with their academic achievement. I am very proud of the work our faculty and staff have done with our students to get us to this point. However, we won't settle for where we are. We will continue to see ways to improve and grow to provide our students with the very best education.

I also want to extend a big THANK YOU to our community for supporting the April 4th ballot items for the school district. The school district has permission for a \$4,000,000 bond issue that will have

a large amount set aside for a possible FEMA shelter to be built. This would double-up as an athletic field house with male and female locker rooms, a large wrestling room, and we would build a storage area onto the outside of the building. The estimated cost for the project would be about \$3.6M, but Sherwood would only pay about \$900,000 with the rest coming from federal money. Again, this is **only** if federal funds become available to us. We are setting aside an additional \$350,000 to fill-in the insides of the building with materials and resources not included in the FEMA building costs (lockers, benches, bulletin boards, etc.). If federal money does not become available, then the Sherwood Board of Education can move forward with building a new wrestling room and designate the other funds to areas of need. Additionally we will purchase HVAC equipment and buses. We will also be able to address remodeling needs around the district as well. Thank you also for approving our \$0.12 operating levy increase! We have already increased salaries that will direct \$53,000 of the new \$85,000 that will be available to us into salaries for our staff. The remainder will be used to address increased costs to supplies and special education costs in the district. You will see no increase to the overall tax rate from 2022 to 2023 as very thankful to have been a part of we will reduce the debt service tax levy by \$0.12. The overall tax rate will remain under \$4.86.

Finally, I want to thank the Sherwood Community for your support over the past 6 years. Leading the Sherwood School District has been a great joy for me. We have such amazing people who do amazing work with our students and community. The Sherwood Community should be very proud of our school. We are just big enough to have to offer a lot of different opportunities for our students, but we are small enough that our staff can get to know the needs of our individual students. I think this shows through with all the different things we offer for our kids - Project Lead the Way classes, online courses, two Ag classrooms, foreign language, dual credit, and so much more. And our students are successful! I think our APR scores (as previously mentioned) goes to show the overall scope of how we provide a quality education for our students. However, we also have graduating classes bringing millions of dollars of scholarships, a special education program that scores high each year on its evaluation by DESE, successful alumni all over the world, students earning athletic and activities recognition, students ready to join the workforce or military and be successful after high school, and so much more! Sherwood Schools really is a special place to be, and I am it!

### Title IA Parents' Right to Know

Dear Parent or Guardian:

Our district is required to inform you of information that you, according to the Every Student Succeeds Act of 2015 (Public Law 114-95), have the right to know.

Upon your request, our district is required to provide to you in a timely manner, the following information:

- Whether your student's teacher has met State qualification and licensing criteria for the grade levels and subject areas in which the teacher provides instruction.
- Whether your student's teacher is teaching under emergency or other provisional status through which State qualification or licensing criteria have been waived.
- Whether your student's teacher is teaching in the field of discipline of the certification of the teacher.
- Whether your child is provided services by paraprofessionals and, if so, their qualifications.

In addition to the information that parents may request, a building receiving Title I.A funds must provide to each individual parent:

- Information on the level of achievement and academic growth of your student, if applicable and available, on each of the State academic assessments required under Title I.A.
- Timely notice that your student has been assigned, or has been taught for 4 or more consecutive weeks by, a teacher who has not met applicable State certification or licensure requirements at the grade level and subject area in which the teacher has been assigned.

# **Public Notice**

#### Missouri Department of Elementary and Secondary Education Every Student Succeeds Act of 2015 (ESSA) COMPLAINT PROCEDURES

This guide explains how to file a complaint about any of the programs<sup>1</sup> that are administered by the Missouri Department of Elementary and Secondary Education (the Department) under the Every Student Succeeds Act of 2015 (ESSA)<sup>2</sup>.

#### 1. What is a complaint?

For these purposes, a complaint is a written allegation that a local education agency (LEA) or the Missouri Department of Elementary and Secondary Education (the Department) has violated a federal statute or regulation that applies to a program under ESSA.

#### 2. Who may file a complaint?

Any individual or organization may file a complaint.

#### 3. How can a complaint be filed?

Complaints can be filed with the LEA or with the Department.

#### 4. How will a complaint filed with the LEA be investigated?

Complaints filed with the LEA are to be investigated and attempted to be resolved according to the locally developed and adopted procedures.

#### 5. What happens if a complaint is not resolved at the local level (LEA)?

A complaint not resolved at the local level may be appealed to the Department.

#### 6. How can a complaint be filed with the Department?

A complaint filed with the Department must be a written, signed statement that includes:

- 1. A statement that a requirement that applies to an ESSA program has been violated by the LEA or the Department, and
- 2. The facts on which the statement is based and the specific requirement allegedly violated.

Local education agencies are required to disseminate, free of charge, this information regarding ESSA complaint procedures to parents of students and appropriate private school officials or representatives.

# **Public Notice**

#### 7. How will a complaint filed with the Department be investigated?

The investigation and complaint resolution proceedings will be completed within a time limit of forty five calendar days. That time limit can be extended by the agreement of all parties.

The following activities will occur in the investigation:

- **1. Record.** A written record of the investigation will be kept.
- 2. Notification of LEA. The LEA will be notified of the complaint within five days of the complaint being filed.
- **3. Resolution at LEA.** The LEA will then initiate its local complaint procedures in an effort to first resolve the complaint at the local level.
- **4. Report by LEA.** Within thirty-five days of the complaint being filed, the LEA will submit a written summary of the LEA investigation and complaint resolution. This report is considered public record and may be made available to parents, teachers, and other members of the general public.
- **5. Verification.** Within five days of receiving the written summary of a complaint resolution, the Department will verify the resolution of the complaint through an on-site visit, letter, or telephone call(s).
- **6. Appeal.** The complainant or the LEA may appeal the decision of the Department to the U.S. Department of Education.

# 8. How are complaints related to equitable services to nonpublic school children handled differently?

In addition to the procedures listed in number 7 above, complaints related to equitable services will also be filed with the U.S. Department of Education, and they will receive all information related to the investigation and resolution of the complaint. Also, appeals to the United States Department of Education must be filed no longer than thirty days following the Department's resolution of the complaint (or its failure to resolve the complaint).

#### 9. How will appeals to the Department be investigated?

The Department will initiate an investigation within ten days, which will be concluded within thirty days from the day of the appeal. This investigation may be continued beyond the thirty day limit at the discretion of the Department. At the conclusion of the investigation, the Department will communicate the decision and reasons for the decision to the complainant and the LEA. Recommendations and details of the decision are to be implemented within fifteen days of the decision being delivered to the LEA.

#### 10. What happens if a complaint is not resolved at the state level (the Department)?

The complainant or the LEA may appeal the decision of the Department to the United States Department of Education.
